**No One Left Behind provided housing assistance for 75 families. Most of these families would have faced eviction and homelessness had the organization not provided this assistance. Families not facing immediate eviction were provided much needed housing security which enabled them to focus on longer-term resettlement requirements like securing adequate employment.**

**No One Left Behind provided transportation assistance to more than 40 families. This included 32 car grants for basic used vehicles, the provision of local transport grants for passes (e.g., bus or subway tickets) taxi or ride-share funds. No One Left Behind has found that personal vehicles opportunities afforded to those with reliable transportation. are the single greatest contribution that can be made to our clients in support of their long-term self-sustainability due to the improved employment.**
